The Holiday season has arrived and the Lodge is busy and doing just great; with the help and support of the Officers and some very dedicated members the Lodge continues to run smoothly. Final nominations for Exalted Ruler for the balance of the Elk year will be held at the December 4th meeting, with balloting to follow. We will continue to monitor this new information and investigate ways we might possibly continue to provide services to these events.

We have a few very significant and meaningful events in December: the first is on Sunday, December 7th when the Lodge will conduct the annual Elks Memorial Service to honor our departed brothers and sisters. The service will start at 1PM, and a reception will follow. All are welcome to attend to pay your respects. Next, the Lodge Christmas Party on December 12th; Keith and Judy Hinchcliffe are preparing the meal and Santa may be making an appearance. We are in the planning stage to choose our Christmas families for this event; Gail Plowman is working on identifying the families and children that need our help. This promises to be a special event for the families, thanks to the grant we detailed last month. Remember Kelley Sadecki, PER, will have the bar open on Christmas day at 2PM so come down, say hello and enjoy the holiday with your Elks family. Finally, plans are being considered to host a New Year's Eve party at the Lodge, so look for information to be forthcoming.

We would again like to thank Bill Douds, PER, for his most generous gift of the Henry Rifle that was raffled off on November 1st. Congratulations to Will Moniot for having won that rifle! The event helped raise over two thousand dollars for the Lodge.
